New Zealand visa fees set to increase w.e.f. 1st October 2024!

- On 9th August 2024, NZ government announced that increase in visa charges will be introduced from 1st October 2024 onwards.
- Currently, the student visa fee is NZD375 and is set to increase by 50%.
- From 1st October 2024, the student visa fee will be NZD750.

MEA reveals the number of Indian students studying abroad in 2024

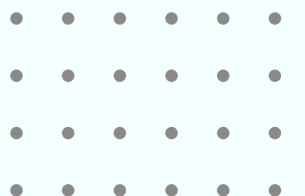
- As per the recent data released by MEA, 13,35,878 Indian students are studying abroad in 2024.
- With 4,27,000 Indian students, Canada is the top host country followed by the USA with 3,37,630, the UK with 1,85,000, Australia with 1,22,202 and Germany with 42,997.
- Medical education is one of the most popular field of studies chosen by Indian students abroad.
- With maximum number of Indian students, Georgia remains the top host country for 16,093 followed by Philippines with 9,665, China with 8,550 and Uzbekistan with 4,100.

University of Oregon, An Agent of Change and Innovation!

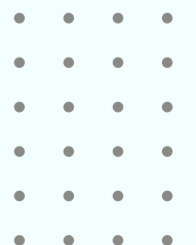
- Founded in 1876, [University of Oregon](#) is in Eugene, Oregon and is one of the Top 50 public universities in the [USA](#).

Get 70% of Tuition Fees Back Through Tax Credit After Studying at **GBS, Malta!**

- Malta is becoming a popular study abroad destination amongst international students for the post study opportunities it offers.
- The average cost of an undergraduate degree at [Global Business School \(GBS\), Malta](#) is EUR6000 per year.
- Under a national scheme which aims at benefitting international students, an international student can claim 70% of their tuition fees back through tax credit with an upper limit of EUR12,500. This is possible provided the student gets a full-time job within 9 months after they graduate.
